# Nominations for Honorary Life Membership

One of the highlights of each annual meeting of PAA is the recognition of persons who have contributed to the betterment of the potato industry. This recognition is made by awarding Honorary Life Memberships (HLM) in The Potato Association of America. This is the highest award bestowed by PAA.

Members of PAA are encouraged to nominate candidates for Honorary Life Membership which will be awarded at the 2003 Annual Meeting in Spokane, Washington. Honorary Life Memberships are awarded to individuals who have made significant contributions to the potato industry and/or to The Potato Association of America. Contributions may be for activities related to research, extension/education, production, processing, marketing, utilization or any other facet of the potato industry.

Nominations must be submitted on the official HLM nomination form, which is available from the PAA Secretary (steven.james@oregonstate.edu), or from the PAA website http://www.ume.maine.-edu/PAA/hlmform.

Nomination information should include details of the nominee's education, career highlights, contributions to the potato industry and any participation in PAA. In addition, nomination information must include letters of recommendation from five supporters of the nominee. These letters must be submitted with the HLM Nomination Form. Supporters of the nominee may not be immediate associates of the individual. Selection of individuals for Honorary Life Membership will be made by the Honorary Life Membership Committee. This committee is composed of the PAA President, President Elect, Vice President, the PAA Directors and the two most recent, living Past Presidents. The immediate Past President serves as chairperson.

#### **Papers**

This is the SECOND CALL for papers to be presented at the 87<sup>th</sup> Annual Meeting of The Potato Association of America. This meeting will be held August 10-14, 2003 in Spokane, Washington.

The PAA invites the submission of papers dealing with all facets of the potato industry. Members may present papers either orally or as poster papers. Researchers, extension and industry persons are invited to participate. Graduate students are also encouraged to enter the Graduate Student Competition.

Authors are required to submit abstracts for papers they wish to present, whether orally, as poster papers or in the Graduate Student Competition. Prior to submitting your abstract, please carefully read and follow the formatting guidelines published on the PAA website. The entire abstract (title, authors and body) should be no more than 2,000 characters, including spaces. All abstract submissions should include the title, authors, presenter, presentation method, section (breeding, pathology, etc.) and if it is to be included in the Graduate Student Competition. Submit abstracts as an e-mail attachment to steven.james@oregonstate.edu and list "PAA Abstract" as the e-mail subject.

The abstracts for all papers (oral, poster and Graduate Student Competition) presented at the Annual Meeting will be published in a postmeeting issue of the *American Journal of Potato Research*. Abstracts of papers listed in the meeting program, but not presented, will not be published in the AJPR.

At the annual meeting, all oral paper presentations will be of a uniform 15-minute length. Authors should plan a 12 to 14-minute presentation with the balance of time devoted to questions. Slide and electronic projectors will be available. Overhead projector presentations are discouraged. Electronic presentations are highly encourage and must be prepared in Microsoft PowerPoint 2000 format or lower (the only acceptable software). Presenters must save their presentations on a CD which has been clearly marked with presenter's name and presentation title. The CD must be delivered to the audio/visual desk at the conference no later than 5:00 pm on the day before the scheduled presentation. Projectionists/computer operators will be available to load the presentation into the laptop computer available for each session.

Following the presentation, at the end of the session, your CD will be available for pick up from the projectionist or session moderator. Please note: It will not be possible for presentters to use their own laptop computers for presentations in sessions due to insufficeint time between talks to disconnect and reconnect computers. A visuals viewing room will be available to help you prepare for your presentation. Contact Dr. Rick Knowles, WSU, by email at rknowles@wsu.edu or by phone at (509) 335-3451, 10 days prior to meeting if special audio/visual requirements are necessary.

Overhead, slide and electronic projectors will be available. Display boards (4 ft by 4 ft) will be provided for the poster papers.

The deadline for submitting abstracts is March 15, 2003. Abstracts submitted after that date will be returned because of the time required to organize the program prior to the meeting.

#### **Graduate Student Competition Papers**

This is the **SECOND CALL** for papers to be entered in the Graduate Student Awards Competition to be held at the 87th Annual Meeting of The Potato Association of America. This meeting will be held August 10-14, 2003 in Spokane, Washington.

The purpose of the Graduate Student Awards Competition is to promote graduate student participation in The Potato Association of America through presentation of research papers at the Annual Meeting. Participants are also encouraged to submit manuscripts for publication in the *American Journal of Potato Research*.

#### **General Information**

- The author must be a current (or recent) graduate student at the time the abstracts are due (March 15, 2003). At least one co-author on the abstract must be a member of the PAA.
- 2. First place winners from previous PAA meetings are not eligible to participate.
- Research reported must have been done while a graduate student.
- The paper must be orally presented. Poster papers and symposium presentations do not qualify for the Graduate Student Awards Competition.
- Only one presentation by a student may be entered into the Graduate Student Competition at a PAA meeting. The student may give other presentations that are not entered.
- 6. The paper must be submitted to the PAA Secretary as outlined in the First Call for Papers. The total length, including title, authors and abstract body should not exceed 2,000 characteristics. The author must indicate discipline and that the paper is entered in the Graduate Student Awards Competition.
- 7. Winners will be announced and honored at the Annual Banquet. Free banquet tickets will be provided by PAA for all graduate students participating in the Graduate Student Awards Competition.

#### **General Criteria for Judging**

Papers and presentations will be judged on the following basis.

- 1. Quality of research and content 60%
- 2. Effectiveness of presentation 40%

#### **Awards**

Five awards will be presented in the amounts of \$350 for first place, \$250 for second place, \$150 for third place, \$100 for fourth place, and \$100 for fifth place.

Historic Walking Tour of Downtown Spokane: Stroll the paths of our early settlers starting at Riverfront Park and the downtown core. At the Spokane Falls hear the legend Native Americans tell of its formation. Hear the fascinating story of Kirtland Cutter who designed many of the buildings located here in the 1800's including the famous Davenport Hotel. Look through the Steam Plant constructed in 1915, it provided steam heat and electric power for downtown Spokane until 1986. Its twin 225 ft. smoke stacks were hand formed, using 333,340 bricks. Return to the hotel or stay and have

dinner at the Steam Plant Bar & Grill or The Davenport Hotel. Cost: \$9.00 per person includes tour guide. Time: 2 hrs.

**Golf Scramble**: Enjoy a fun golf competition with other PAA members, their families and friends at one of the Pacific Northwest's premier golf courses. Teams will be divided evenly with beginner, intermediate, and handicap level players. Prizes will be given out at the end. Cost: \$45.00 per person includes transportation, green fees and cart. See the historic area of Brown's Addition where many of the old mansions are being restored to their original splendor. Tour the Crosbyanna Room at Gonzaga University to see Bing Crosby memorabilia. ### **Members in the News**

As I'm sure many of you already know, Dr. Robert E. Hanneman, Jr., passed away on Friday, October 18, 2002, after a courageous 2-1/2 year battle with cancer. He is survived by his wife, Betty, daughter, Suzanne, and Son, Jonathan. Bob was born in Wisconsin Rapids in 1942 and received all three of his degrees at the Univ. of Wisc.-Madison, including a B.S. in Biochemistry, an M.S. in Genetics, and a Ph.D in Plant Breeding & Genetics. In 1974 he obtained a position as a Research Geneticist for the USDA, ARS in the Dept. of Hort., Univ. of Wisc.-Madison. Bob became world known for his discovery of an economically important biological isolating mechanism in potato, referred to as "Endosperm Balance Number." Bob was a member of the PAA's breeding & genetics section.

We also had another loss of a long time member, **Wayne D. Thompson**, died June 2, 2002 after a valiant struggle with cancer. His wife, Maryann, of

25 years, and two daughters, Dawn and Kali, survive him. Wayne was born in 1934 in Monte Vista, Colorado. He graduated from Adams State College in 1956 and entered the U.S. Marine Corps for 21 years. After his retirement from the service, Wayne was the Executive Director of the Colorado Potato Admin. Committee for 18 years until his illness. He was a member of the PAA certification section and a sponsor of a sustaining membership in the PAA.

## LAC 2002 Report

The 86<sup>th</sup> Annual Meeting of the Potato Association of America was held in Toronto, Ontario, August 11-17<sup>th</sup>, in conjunction with the 26<sup>th</sup> International Horticultural Congress.

A total of 160 PAA delegates, plus 60 family members, attended the meeting, coming from 22 states, 9 provinces and 9 other countries. In addition, 23 guests from the Potato Symposium of the IHC joined PAA members at the President's Reception and Awards Banquet. The IHC was attended by a total of 2751 delegates from over 80 countries. More than 2500 oral, poster and workshop papers were presented. The four day Potato Symposium, sponsored by the PAA, consisted of 33 oral and 76 poster presentations. These papers will be published in an upcoming volume of Acta Horticulturae. As well, each of the seven PAA sections hosted an evening workshop, all of which were well attended. The final 'potato' event was an industry tour held Saturday August 17th, touring the Alliston area, and attended by 35 delegates.

On the financial side, almost \$42,000 (Cdn funds) was raised in support of PAA business

and social functions. Also, \$12,000 (Cdn funds), including funds from IHC and PAA, were raised in support of the IHC Potato Symposium. Monies came from a total of 14 sponsor companies and organizations. All registration, other tours, and scientific meeting facilities were handled by the IHC organization.

I would like to thank my LAC, with specific thanks going to Richard Tarn, IHC-PAA liaison; Rickey Yada, symposium convener; Greg Vallee, AV support; Eugenia Banks, industry tour organizer; and Lori Wing, Webmaster. Special thanks go to Norm Looney and Al Sullivan of the IHC.

Both Rickey Yada and Al Sullivan (president of CSHS) addressed the Annual Meeting of the PAA to express their appreciation to the PAA for participating in the IHC 2002. Rickey Yada presented a commemorative medal to the PAA from the IHC.
