First Call for Papers

This is the First Call for Papers to be presented at the 94th Annual Meeting of The Potato Association of America, to be held August 15-19, 2010 at the CH2M HILL Alumni Centre, Oregon State University, Corvallis, Oregon USA. The recommended hotel, Hilton Garden Inn, is a short walk from the conference facility.

PAA members are invited to present papers dealing with all facets of the potato industry. Graduate students who are PAA members are encouraged to enter the Frank L Haynes Graduate Student Research Competition.

Authors are required to submit abstracts for papers they wish to present, whether orally, as a poster or in the Frank L Haynes Graduate Student Research Competition. The abstracts for all papers (oral, poster and Graduate Student Research Competition) presented at the Annual Meeting will be published in a postmeeting issue of the *American Journal of Potato Research*. Abstracts of papers listed in the meeting program, but not presented, will not be published in the *AJPR*.

At the Annual Meeting, all oral paper presentations will be of a uniform 15-minute length. Authors should plan a 12- to 14minute presentation with the balance of time devoted to questions. Computer projectors will be available for PowerPoint presentations. Please bring your PowerPoint presentation (2007 or earlier version) on a portable USB drive.

Display boards will be provided for posters. Maximum poster size is 4 feet wide x 3 feet tall (48 inches wide x 36 inches tall).

Abstracts will be accepted until March 19, 2010. Submit abstracts as an e-mail attachment to loretta.mikitzel@gnb.ca with "PAA Abstract" as the e-mail subject. You will receive an email acknowledging receipt of the abstract. Abstracts submitted after that date will be returned to the author.

Abstract submission checklist:

- 1. Title
- 2. Author(s) with Presenter's name underlined
- 3. Body of Abstract
- 4. PAA Membership Number of one (1) author
- 5. Presentation Method (oral; oral graduate student; poster)
- 6. Section (breeding and genetics, plant protection, physiology, utilization and marketing, extension, production and management or certification)

Abstract length:

Abstract length is a <u>maximum of 2,000 characters</u>. This size limit includes spaces and pertains to the combined abstract title, authors and their affiliations and the body of the abstract. <u>Only the first 2,000 characters will be printed in the program</u>- please keep your abstract within the maximum allowable length.

Prior to submitting your abstract, please read and follow the formatting guidelines that are posted on the PAA website http://potatoassociation.org and will be posted on the conference website when it is available.

Abstracts will be accepted until March 19, 2010.

Nominations for Honorary Life Membership

One of the most significant ways to recognize outstanding contributions to the potato industry and to our organization, The Potato Association of America, is the awarding of Honorary Life Membership (HLM). This is the highest award bestowed upon an individual by The PAA. Each year at the Annual Meeting of The PAA this award is given to deserving individuals and is considered by many attendees the highlight of the banquet.

PAA members are encouraged to nominate candidates for HLM to be presented at the 2010 Annual Meeting in Corvallis, Oregon. Nominated individuals should have made significant contributions to the potato industry and/or The PAA. Contributions may come from activities related to research, extension, education, production, processing, marketing, utilization or any of the other facets of the potato industry which may be appropriate. HLM awards can be given to individuals outside of the PAA.

Nominations must be submitted using the official HLM nomination form available on the PAA Website: http://potatoassociation.org/index/html. The selection procedure and desired candidate information is also available in the same area on the Website. Completed HLM nominations and all supporting documentation should be submitted electronically in MS Word or PDF format to Past President Chuck Brown and are due by March 19, 2010.

All members should take the time to think about their colleagues and their service to the industry to see if they might qualify for HLM in The PAA. This is a wonderful award and recognition, but it can not happen without going through the nomination process.

Frank L Haynes Graduate Student Research Competition Papers

This is the First Call For Papers to be entered in the Frank L Haynes Graduate Student Research Competition (GSRC) to be held at the 94th Annual Meeting of The Potato Association of America.

The purpose of the GSRC is to promote graduate student participation in PAA through presentation of research papers at the Annual Meeting. Participants are also encouraged to submit manuscripts for publication in the *American Journal of Potato Research*.

General Information

- 1. The author must be a current (or recent) graduate student at the time the abstracts are due March 19, 2010.
- 2. First place winners from previous PAA meetings are not eligible to participate.
- Research reported must have been done while a graduate student.
- 4. The paper must be orally presented. Poster papers and symposium presentations do not qualify for the FLHGSRC.
- 5. Students are required to submit abstracts for papers they wish to present in the Competition via e-mail. Abstracts will be accepted until March 19, 2010.
- 6. No new students may register after the deadline or at the meeting.
- 7. Winners will be announced and honored at the annual banquet. Participants will receive a free Banquet ticket for themselves supplied by the LAC.
- 8. Graduate students must be members of the PAA and may not use their advisor's ID. (**Membership information is found on The PAA website at:

http://www.potatoassociation.org/index.html)

General Criteria for Judging: Papers and presentations will be judged on the following basis:

- A. Quality of research and content: 60%
- B. Effectiveness of presentation: 40%

Up to five awards may be made at the discretion of the committee in the amount of \$350 for 1st place, \$250 for 2nd place, \$150 for 3rd place, \$100 for 4th place, \$100 for 5th place.

Call For Nominations for Outstanding Extension Project Award

The Outstanding Extension Project Award was developed in 2009 by the Extension Section of The PAA to recognize outstanding Extension projects or programs, printed publications, websites, workshops, newsletters, etc., that have made significant contributions to education on potato. At this time the Selection Committee is seeking nominations due by March 19, 2010 for this award to be presented at the 94th Annual Meeting in Corvallis, Oregon. Information pertaining to this award and the selection process is presented below:

A. Award Recipient Eligibility:

- 1. The nominated Recipient must be a member in good standing with The PAA. For team nominations, at least one person must be a member in good standing with the PAA.
- 2. Although the Recipient need not have an Extension appointment, the project or program must be related to Extension-type activities. The project or program must be either on-going at the time of the Annual Meeting the year of recognition or have been completed no more than 30 months (2.5 years) prior to the Annual Meeting in the year of recognition.
- 3. The Recipient must attend the Annual Meeting to receive the award, unless exempted by the selection committee because of extenuating circumstances.
 - 4. Nominators do not have to be members of The PAA.

B. Selection Process

- 1. No more than one Extension Award will be presented at any Annual Meeting of The PAA.
- 2. The Selection Committee consists of the current officers of the Extension Section plus the past Extension Section chair who shall serve as chair of the Outstanding Extension Project Award Selection Committee.
- 3. Nominator must complete the nomination form, that is available on the PAA website, along with submitting a written review, not to exceed 1000 words, of specific project or program being nominated for the Award.
- 4. At least two letters of support must also be sent to the selection committee chair.
- 5. Nomination form, written review, and letters of support must be submitted to the selection committee Chair no later than March 19, 2010. For further information, please see the website: http://potatoassociation.org/

93rd Annual Meeting of The Potato Association of America ReCap

The 93rd Annual Meeting of The Potato Association of America was held August 9-13, 2009 at the Delta Fredericton Hotel in Fredericton, New Brunswick Canada. We hosted 220 delegates and 41 accompanying persons, from 13 countries, 8 Canadian provinces and 21 US states. The meeting began with a pre-Conference Breeding and Genetics Workshop "Application of Genomic Resources to Potato Breeding" on Sunday afternoon, followed by the President's reception. Monday began with two bagpipers and one drummer in full kilted regalia piping in local dignitaries and the speakers of the morning's Plant Protection Symposium "Alternative Methods of Pest and Disease Control". Monday afternoon, Tuesday morning and Thursday morning featured 104 concurrent session papers and posters including 10 graduate student competition papers. On Tuesday afternoon a special "International

PVY Symposium" was held with seven speakers from Poland, China, USA and Canada. The poster session was in conjunction with the silent auction that evening and delicious potato hors d'oeuvres were served.

Wednesday featured two delegate tours. The agricultural tour, with 85 delegates traveled up the Saint John River valley and toured New Brunswick's Potato Belt. Thirty-one delegates toured Fredericton's potato research facilities and lunched at Odell Park.

A Maritime Kitchen Party steak and lobster BBQ was on Wednesday evening at the Riverside Resort where President Chuck Brown raised funds for The PAA Endowment Fund with his "Presidential Canoe Paddle". The 145 guests enjoyed the live Celtic entertainment by the band Brollachan. A few hardy souls stayed to watch the meteor shower by a bonfire on the shore.

The annual business meeting was held on Thursday afternoon. The PAA Awards Banquet was on Thursday evening, where Dennis Johnson, Rudra Singh and Richard Tarn received their Honorary Life Membership, Al Mosley was the first to be honored with the Outstanding Extension Project Award and Agnes Murphy was recognized as Potato Grower Magazine Researcher of the Year.

The week's events enjoyed by accompanying persons included a Fredericton Culture Crawl, whale watching, Kings Landing visit and Hopewell Rocks tour. The 93rd Annual Meeting concluded with two post-conference trips – whale watching and salmon fishing.

Update on AJPR September 1, 2009

Colleagues,

There is good news to report regarding AJPR's progress under partnership with Springer Publishing, now in effect for almost 2 years. Submissions are up nearly 20%. In the past, we marketed AJPR to less than 250 libraries and institutions. We now have about 3.400 institutional outlets worldwide. AJPR is available on-line, including complete back issues for PAA members. This has resulted in an amazing 46,500 PDF downloads in the past year. So lack of visibility is no longer a reason for authors to avoid publishing in AJPR. Technical editing, printing and distribution are now done by Springer, freeing PAA volunteers on the Editorial Board to focus on reviewing the science and determining sound editorial policies. Even better, moving away from our historic doit-yourself publication structure has resulted in a significant financial advantage to The Association. Last year our direct payments to Springer for publishing were about \$22K, but their return to us in royalties plus editorial stipend was about \$24K—that is, a 9% profit not counting page charge income. Scientific publishing is rapidly changing, and it will be our challenge to keep AJPR advancing with it. Your comments to me or other members of the AJPR Editorial Board to that end are always welcome.
