t was an interesting, informative and fun annual PAA meeting held August 15-19 in Corvallis, Oregon. The LAC chairs Philip Hamm and Russ Ingham and their crew conducted a very successful and productive meeting and are to be commended for all their time and hard work. There were 130 paper and poster presentations, a symposium on the sustainability of potato production hosted by the Extension Section, a SolCap workshop, seven section meetings, three tours, the annual business meeting and awards banquet all compacted into four days. Attendance was 209 from 22 states, 6 provinces, and 11 counties, which attests to the diversity and strength of our organization. We do represent the scientific and educational efforts which support the potato industry of the US and that of the world. foster communication among the potato community, and conduct our mission of education. First Call for Papers

his is the First Call for Papers to be presented at the 95th Annual Meeting of The Potato Association of America, to be held August 14-18, 2011 at the Hilton Wilmington Riverside Hotel, Wilmington, North Carolina, USA.

PAA members are invited to present papers dealing with all facets of the potato industry. Graduate students who are PAA members are encouraged to enter the Frank L Haynes Graduate Student Research Competition.

Authors are required to submit abstracts for papers they wish to present, whether orally, as a poster or in the Frank L Haynes Graduate Student Research Competition. The abstracts for all papers (oral, poster and Graduate Student Research Competition) presented at the Annual Meeting will be published in a post-meeting issue of the *American Journal of Potato Research*. Abstracts of papers listed in the meeting program, but not presented, will not be published in the *AJPR*.

At the Annual Meeting, all oral paper presentations will be of a uniform 15-minute length. Authors should plan a 12- to 14-minute presentation with the balance of time devoted to questions. Computer projectors will be available for PowerPoint presentations. Please bring your PowerPoint presentation (2007 or earlier version) on a portable USB drive.

Display boards will be provided for posters.

Abstracts will be accepted until Monday, March 21, 2011. Submit abstracts as an e-mail attachment to loretta.mikitzel@gnb.ca with "PAA Abstract" as the e-mail subject. You will receive an email acknowledging receipt of the abstract. Abstracts submitted after that date will be returned to the author.

Abstract submission checklist:

- ${\it 2. Author (s)} \ and \ their \ affiliations. 3 Presenter's \ name \ underlined$
- 3. Body of Abstract

Maximum length of $\underline{2,000 \text{ characters}}$. This size limit includes spaces.

- 4. PAA Membership Number of one (1) author
- 5. Presentation Method (oral; oral graduate student; poster)
- 6. Section (breeding and genetics, plant protection,

 $physiology, utilization \ and \ marketing, \ extension, \ production \ and \ management \ or \ certification)$

Only the first 2,000 characters will be printed in the program- please keep your abstract, including title, authors and their affiliations, within the maximum allowable length.

Prior to submitting your abstract, please read and follow the formatting guidelines that are posted on the conference website (http://paa2011.org) and on the PAA website (http://paa2011.org).

Nominations must be submitted using the official HLM nomination form available on the PAA Website: http://paa2011.org. The selection procedure and desired candidate information is also available in the same area on the Website. Completed HLM nominations and all supporting documentation should be submitted electronically in MS Word or PDF format to Past President Phil Nolte and are due by March 21, 2011.

All members should take the time to think about their colleagues and their service to the industry to see if they might qualify for HLM in The PAA. This is a wonderful award and recognition, but it can not happen without going through the nomination process.

Frank L Haynes Graduate Student Research Competition Papers

This is the First Call For Papers to be entered in the Frank L Haynes Graduate Student Research Competition Award (GSRCA) to be held at the 94th Annual Meeting of The Potato Association of America.

The purpose of the GSRCA is to promote graduate student participation in PAA through presentation of research papers at the Annual Meeting. Participants are also encouraged to submit manuscripts for publication in the *Ameri J of Potato Res.*

General Information

- 1. The author must be a current (or recent) graduate student at the time the abstracts are due March 21, 2011.
- 2. First place winners from previous PAA meetings are not eligible to participate.
- 3. Research reported must have been done while a graduate student.
- 4. The paper must be orally presented. Poster papers and symposium presentations do not qualify for the FLHGSRCA.
- 5. Students are required to submit abstracts for papers they wish to present in the Competition via e-mail. Abstracts will be accepted until March 21, 2011.
- 6. No new students may register after the deadline or at the meeting.
- 7. Winners will be announced and honored at the annual banquet. Participants will receive a free Banquet ticket for themselves supplied by the LAC.
- 8. Graduate students must be members of the PAA and may not use their advisor's ID. (**Membership information is found on The PAA website at: http://potatoassociation.org

General Criteria for Judging: Papers and presentations will be judged on the following basis:

- A. Quality of research and content: 60%
- B. Effectiveness of presentation: 40%

Up to five awards may be made at the discretion of the committee in the amount of \$350 for 1st place, \$250 for 2nd place, \$150 for 3rd place, \$100 for 4th place, \$100 for 5th place.

Call For Nominations for Outstanding Extension Project Award

The Outstanding Extension Project Award was developed in 2010 by the Extension Section of The PAA to recognize outstanding Extension projects or programs, printed publications, websites, workshops, newsletters, etc., that have made significant contributions to education on potato. At this time the Selection Committee is seeking nominations due by March 21, 2011 for this award to be presented at the 95th Annual Meeting in Wilmington, North Carolina. Information pertaining to this award and the selection process is presented below:

A. Award Recipient Eligibility:

- 1. The nominated Recipient must be a member in good standing with The PAA. For team nominations, at least one person must be a member in good standing with the PAA.
- 2. Although the Recipient need not have an Extension appointment, the project or program must be related to Extension-type activities. The project or program must be either on-going at the time of the Annual Meeting the year of recognition or have been completed no more than 30 months (2.5 years) prior to the Annual Meeting in the year of recognition.
- 3. The Recipient must attend the Annual Meeting to receive the award, unless exempted by the selection committee because of extenuating circumstances.
 - 4. Nominators do not have to be members of The PAA.

B. Selection Process

- 1. No more than one Outstanding Extension Project Award will be presented at any Annual Meeting of The PAA.
- 2. The Selection Committee consists of the current officers of the Extension Section plus the past Extension Section chair who shall serve as chair of the Outstanding Extension Project Award Selection Committee.
- 3. Nominator must complete the nomination form, that is available on the PAA website, along with submitting a written review, not to exceed 1000 words, of specific project or program being nominated for the Award.
- 4. At least two letters of support must also be sent to the selection committee chair.
- 5. Nomination form, written review, and letters of support must be submitted to the selection committee Chair no later than March 21, 2011. For further information, please see the website: http://potatoassociation.org/

2011 PAA Meeting Update 95th Annual Meeting The Potato Association of America August 14-18, 2011 Wilmington, North Carolina USA

The 2011 LAC is pleased to announce that The 95th Annual Meeting of The Potato Association of America will be held August 14 - 18, 2011 at the Hilton Wilmington Riverside Hotel in Wilmington, North Carolina. For details on the Wilmington Hilton, please see http://www.wilmington hilton.com/. Our conference hotel is located on the Cape Fear River in beautiful downtown Wilmington, NC. It is located on the boardwalk and is surrounded by lots of historical features, including the historic Battleship North Carolina. There are plenty of attractions and dining options within walking distance of the hotel to enjoy, as well as several great beaches just a short drive away. The conference hotel is only 5 miles from Wilmington International Airport and it has a free shuttle. For those seeking a larger airport with more connections and airlines you may want to consider flying into Raleigh Durham International Airport (RDU), which is roughly 2.5 hrs north of Wilmington and an easy drive down I-40 east to Wilmington. Members in the News

It was with great sadness that we lost another PAA Honorary Life Member (HLM) on August 29. James E. Bryan received his HLM status in 1992. He grew up with a love for potatoes and entered the Univ of Idaho in 1948. His schooling was interrupted by the Korean conflict for 2 years while in the Army, then came home and received both his B.S. and M.S. degrees in agricultural education in 1956. He taught vocational agriculture for four years before beginning his formal potato career as Area Potato Extension Specialist with the Univ of ID located in Bingham County.

In 1966, Jim joined forces with Dr. Richard L. Sawyer and the NCSU potato program in Peru building a seed program. This was the beginning of a 25-yr relationship with Peru. When the program ended he moved to the newly created Intern'l Potato Ctr (CIP) in Lima as Seed Production Specialist. There he had the leadership role in all aspects of seed production. At CIP he was known as "Mr. Potato" for his detailed knowledge on utilization of germplasm in developing countries.

Since 1961 Jim had been an active PAA member, serving as Director of The Association, Chair of Membership and Intern'l Relations Committees, as well as being active in the Certification Section. He was also an avid potato stamp collector gathering and sending them to other collectors all over the world.

PRESS RELEASE: PAA Sustaining Member, Pest Pros Inc, Plainfield, WI has been granted a trade mark for its Storage Potato Disease Risk Indexing system to be known as STORECAST. The system is the first of its kind potato storage disease and inventory management tool. Based on molecular disease diagnostic techniques known as PCR (polymerase chain reaction), STORECAST measures the storage disease risk for soft rot, leak and pink rot. Late blight, dry rot, silver scurf, early blight and black dot can also be included in the pathogen screen. Two seasons of data from 2008 and 2009 on 64 fields comparing storage rot forecasts to the final storage rot outcome show a 76 percent accuracy rate for close or full agreement on processed potato varieties. Over the two seasons only a 3 percent rate of seeing substantially more rot than expected occurred. Pest Pros Inc. is currently pursuing licensing agreements with others to provide the system in other areas. notice. There will only be TWO reminders before you will be dropped from the system on 12/31/2010. Do not wait until 12/31/2010 to send it, as noted on the invoice, that's when your membership EXPIRES, not to when you have time to pay.

~ If you are retiring this year or do not plan on renewing, remember we now have an "Emeritus" category for folks who were once Individual Members.
